3. On the issue: Information on the amount of funds in the account of the fund of the Alumni Association

On the agenda item, Executive Secretary of the Board of Trustees Smagulova Galia Serikovna said that

the total amount of the Alumni Association fund as of 10/31/2019 is: 3,498,429.00 tenge.

Of these, the balance at the beginning of the year is 2,968,900.00 tenge;

Receipt of funds, total - 1 327 769.00 tenge;

Including sponsorship from A. Kibarin - head of the Department of Thermal Power Plants AUES - 200 000 tenge;

Membership fees of legal entities - 200 000 tenge:

Plant "Electrocable", IPK "Zhersu";

Sponsorship of individuals - 385,500 tenge;

Sponsorship of legal entities - 252,000 tenge Elektrokabel Plant;

Sponsorship from the AUPET Alumni Association - 290,269 tenge.

On April 29, 2019, Bekbas Orazbek Telbaevich, a 1977 AUES graduate, member of the AUES Board of Trustees, delivered a guest lecture at AUES on the subject of "Trade Unions in the Field of Energy and Social Partnership". He told me what a trade union is like, which means a collective agreement, its significance in this enterprise.

Upon completion, certificates for sponsorship in the amount of 370,000 tenge were awarded to orphans and children left without parental care: from PA Kazenergoprofsoyuz - 5 students each 50,000 tenge; from companies "Energosbyt", "AIES" and "AZhK" - 3 students each for 40,000 tenge.

On the proposal of the directors of the institutes with supporting documents. The minutes of the meeting is attached.

Kenzhebekov Omirzak Genzhebekuly, graduate - 2012, an orphan, in 2018 contributed to the Fund of the Association of Alumni of AUES in cash - 1,495,000 tenge.

Of this amount, financial assistance was paid to 20 students of 63,000 tenge each. The order is attached.

In 2019, Kenzhebekov Omiryzak Kenzhebekuly made an application of 100,000 tenge to pay a one-time scholarship of 20,000 tenge to five students of the Institute of Electric Power and Electrical Engineering, a statement by Kenzhebekov U.K., Order No. 25 for the university is attached.

The nominal scholarship of Daukeev Gumarbek Zhusupbekovich 619 255 tenge was paid to Dauletova Laura аныuanyshbekқуzy, a student of gr. RETk-15-5, order No. 451, payment date from 09/26/2018 to 06/30/2019 from the university.

4. On the issue: Consideration and approval of the amount of financial assistance to students from among orphans and children left without parental care from the Alumni Association fund for the 2019/20 academic year

On this issue, Rector Saule Savetovna Sagintayeva said: "At the beginning of the academic year, in 2019, the number of students from among orphans and children left without parental care is 16 people; all are trained on a grant. In order to educate students about the need for professional self-fulfillment, gaining practical skills of a specialist, financial independence, it is proposed to continue to provide assistance in finding employment in practical training for targeted employment after graduation from 4th year students from among orphans and children left without parental care.

I propose to establish the amount of financial assistance for students from among orphans and children left without parental care in the amount of the state scholarship in 2019 of 21,000 tenge and to make payments from 1.11.2019 to 06.30.2020 to the following students:

Having heard the speech of the rector Sagintayeva S.S. Board of trustees DECIDED:

1. To approve the amount of monthly financial assistance from the fund of the Alumni Association to students from among orphans and children left without parental care in the amount of 21,000 tenge each.

2. The payment of the specified material assistance shall be made on the days of the scholarship payment to students.

4. To provide assistance in finding job placement for fourth-year students from among orphans and children left without parental care for targeted employment after graduation.

5. On the issue: Consideration and approval of nominal scholarships to needy students from the company

On this issue, Vice-Rector for Scientific and Innovative Activities Saukhimov Almas Abzhalievich, said that 2 personal scholarships were established for needy students from poor families from:

1. LLC "Electrocable Plant" General Director Boris Vladimirovich Artemenko, AEI graduate, member of the Board of Trustees - an amount of 252,000 tenge was received;

2. Andrey Anatolyevich Kibarin, AEI graduate, Head of the Department of Thermal Power Plants, AUES, Ph.D., Professor, AUES - in the amount of 200,000 tenge;

In the monthly amount of the state scholarship of 21,000 tenge, students are offered nominations from our institutes.

The Institute of Electric Power and Electrical Engineering offers, through competitive selection for a nominal scholarship, Electrocable Plant LLP

General Director Artemenko B.V. - Kunanbaeva Ayala Dumanovna, 3rd year student of the specialty 5V071800-Power engineering c. EEk-17-3, studying on a grant, the social status of an orphan, the average score for the period of study is GPA-3.29.

The Institute of Management Systems and Information Technologies offers a nominal scholarship to A. Kibarin Head of the Department of Thermal Power Plants of AUES, according to the results of competitive selection - Әділсары Асилбек Әділсарыұлы, 2nd year student of specialty 5B100200-Information Security Systems, group SIBk-18-3, is studying on a grant, social status is an orphan, the average mark for the period of study is GPA -3.9.

CEO of Crypto Consulting Group crypto trader Kenzhebekov Omiryzak Kenzhebekuly, AUES graduate initiated a personal scholarship Smaryl Shakiratu Asylbekuly, 4th year student, specialty 5V071800 Electric power c. EE (ESS) -16-5, studying on a full-paid basis, a student from an incomplete and large family (3 children under 18 years of age), the average score for the period of study is GPA-2.85. Having listened and discussed the student candidacy, the Board of Trustees DECIDED: 1. To approve in a monthly amount of 21,000 (twenty one thousand) tenge:

1.1. Kunanbaeva Ayala Dumanovna, a student of gr. EEk-17-3 for a nominal scholarship of Zavod Elektrokabel LLP General Director BV Artemenko, member of the Board of Trustees, graduate of AEI;

1.2. Ədilsary Asylbek Ədilsaryyly, city SIBk-18-3 for a nominal scholarship of A. Kibarin Head of the Department of Thermal Power Plants AUES;

1.3. Smakl Shakiratu Asylbekuly, gr. EE (ESS) -16-5 for the nominal scholarship of the Crypto Consulting Group CEO Cryptotrader xe.K. Kenzhebekov, member of the Board of Trustees, AUES graduate.

2. The payment of the above scholarships shall be made from the funds of the Alumni Association fund on the days of the scholarship payment to students.

3. To consider a nominal scholarship from November 1, 2019 to June 30, 2020.

## On question 6. Questions of additional certification of students in the field of energy, IT-technologies.

Rector Saule Saetovna Sagintayeva spoke on this issue and reported that the current technology of training prepares bachelors, masters, PhD doctors, but not engineers. Enterprises and other organizations that can assign qualifications give certificates of a specialist, engineer. This is a niche for them, where there is more commercial interest. We have a proposal to include production workers in the State Certification for the defense of theses in order to issue Engineer Certificates along with a bachelor's diploma. We wanted to get the support of the Kazakhstan Electric Power Association, as it is an industry organization. We have the right to do this through the Institute for Advanced Studies and give certificates taking into account regulatory acts. Along with a bachelor's diploma, we will present graduates with an engineering certificate. Students take advanced courses. In the defense of theses, a certain part will be counted as a project activity. This is not possible without an industry enterprise. As a university, we can only give an education diploma. On the basis of our university, together with the Institute for Advanced Studies and the Kazakhstan Electric Power Association, the certification authority center can be opened and an engineer certificate issued with a diploma. This would be useful for our graduates and the employer receives a certified qualified specialist. In order to further develop and implement scientific research, the formation of business entrepreneurship will help sustainable development of the university, the rector emphasized.

The Chairman of the Board of Directors of the non-profit joint-stock company AUES Serikbek Zhusupbekovich Dukuy supported the idea: "They took a very right direction. When a graduate receives a bachelor's diploma, goes to production, he doesn't have certain tolerances that allow him to hold a full-fledged position. The list of these tolerances must be determined together with the employer, if you need any subjects, courses should be included in the curriculum of the advanced training institute, where students can go through and get these tolerances. Suppose, in geology, the word "mining" is added - a mining engineer is a geophysicist and he has access to blasting, i.e. narrow direction, the same in the IPC to include, here he should have the right to do it. To do this, teachers are required, not necessarily full-time, you can invite specialists from outside, from enterprises, to conclude an agreement. They give a course of lectures, it is only necessary to confirm and certify this course. " "We must contact the Kazakhstan Electric Power Association with a letter, work through this issue," concluded the Board of Trustees.

# On item 7. Miscellaneous

7.1. Action Plan for the 45th anniversary of AUPET

All events should be dedicated to the 45th anniversary of the university. We need to attract the media and give them the names of graduates who can respond well to the university. We need to pass the baton on all social networks to Facebook, contact, etc., under the 45-year-old AUES badge to advertise our university. It is necessary to band out T-shirts with the AUES logo to all companies in Kazakhstan. The gala event is scheduled to be held on the last Saturday of May. It is necessary to organize the presentation of diplomas by outstanding graduates. Through the Ministry of Energy and Education, it is necessary to promote veterans, the best graduates, employees, and faculty of AUPET for government awards. For the promotion of industry workers, the titles of KEA were established - Honored Power Engineer, Honorary Power Engineer, Veteran Power Engineer and Certificate of Merit.

7.2. Presentation of the "Urmet belgisi" medal from the Public Association "Kazenergoprofsoyuz" to the Chairman of the Board of Directors of NPJSC AUES Serikbek Zhusupbekovich Dukuey

On this issue, Bekbas Orazbek Telbaevich, chairman of the public company "Kazenergoprofsoyuz" made the statement: "We, as the Kazakhstan branch trade union of power engineers, are monitoring the situation. During these 2-3 years, I traveled to all 98 enterprises, our graduates are everywhere, it's true. In Ust-Kamenogorsk, Atyrau, Semey everywhere I was met as a native, I do not lose touch, I try to maintain. As a graduate, employee, secretary of the Komsomol Committee of the Energy Institute, I always kept in touch with the university. It so happened that in the executive branch system he always oversaw utilities, energy, and the native institute always supported. The connection with Gumarbek Zhusupbekovich Daukeev was always kind, good and in difficult times we were together. For me, the university is very important.

We have established the "Urmet belgisi" medal, which is awarded to the employer for the social partnership of enterprises, for good communication with the trade union committee, with those organizations that train specialists in this case, power engineers. It is good that you improve, optimize, so that the bachelor receives an engineer certificate. In this big work, the rector, the faculty, the whole team plays the first role. In recent years, the Board of Directors of AOES NAO, which is headed by the respected Serikbek Zhusupbekovich Dukey, has been in this process.

On May 21 of this year, by a decision of the Executive Committee, it was decided to award Daukey Serikbek Zhusupbekovich with the "Kurmet belgisi" medal for his significant contribution to the training of socially active engineers in the energy sector of Kazakhstan.
